### 1. Introduction

Hartland Braai Supplies (referred to as "we," "us," or "our") is committed to protecting your personal information and ensuring its privacy, accuracy, and integrity. This privacy policy outlines how we collect, use, and protect your personal information in accordance with the Protection of Personal Information Act (POPIA), Act No. 4 of 2013, of South Africa.

### 2. Personal Information We Collect

We may collect and process the following personal information about you:

- Payment Information: Credit card details or other payment information for processing transactions.

### 3. How We Collect Personal Information

We collect personal information in the following ways:

- Automated Technologies: We collect information automatically as you interact with our website using cookies and other tracking technologies.
- Third Parties: We may receive personal information about you from third-party service providers, business partners, and public sources.

### 4. How We Use Your Personal Information

We will only use your personal information for the purposes for which it was collected, or for compatible purposes including:

- Transactional Purposes: To process and deliver orders, manage payments, fees, and charges.
- Communication: To send administrative information, such as changes to our terms, conditions, and policies.
- Marketing: To provide you with news, special offers, and general information about other goods and services we offer that are similar to those that you have already purchased or enquired about.
- Website Improvement: To analyze data to improve our website, products, services, marketing, and user experience.

### 5. Sharing Your Personal Information
